# Agile Development vs. Stage-Gate Reviews



## Agile Programs:

- Develop Iteratively
- Learn as they go
- Evaluate working capabilities
- Maximize work not done

## Stage Gate Reviews:

- Assess upon completion
- Assume complete knowledge at evaluation points
- Evaluate schedule / CDRL compliance
- Focus on detailed documentation

**Assumptions and Constraints Differ Between Agile Development and Stage-Gate Reviews**



# What is the value of gate reviews?

- Deliver insight
- Ensure alignment
- Understand risks and costs
- Facilitate data drive decision making
- Provide governance
- Enable course corrections with minimal sunk costs

**Goals are the same for agile and waterfall reviews**



# Applying Agile Values to Reviews

## Agile Value Statement

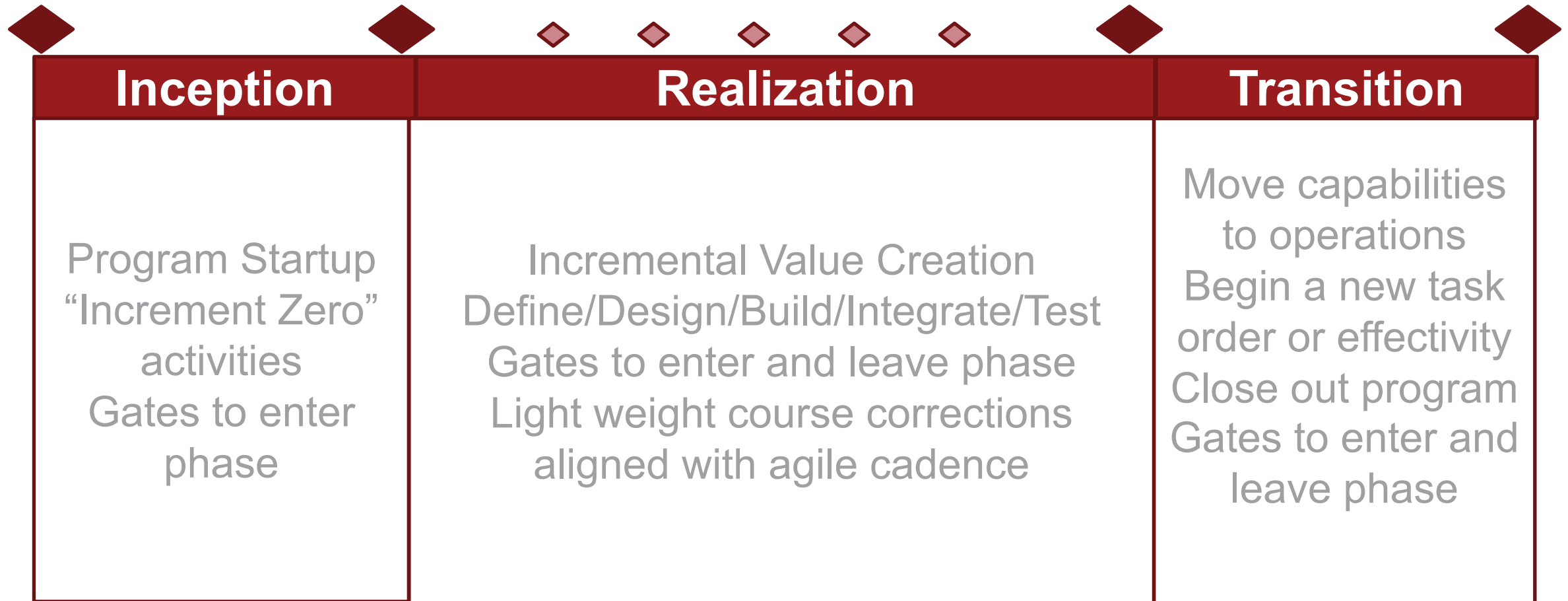
- Individuals and interactions over processes and tools
- Working capabilities over comprehensive documentation
- Customer collaboration over contract negotiation
- Responding to change over following a plan

## Application in Agile Reviews

- Group reviews of core topics supplemented by SME reviews
- Prioritize review of working program artifacts over documents
- Focus on how the contract allows the program to collaborate with the customer to create value
- Frequent light-weight touchpoints rather than rigid go-no go decisions

# Framing Oversight for Agile Programs: Review Focus



- Best practices for agile program execution
- Integration and synchronization
- Working execution assets (e.g. backlog, regression test results, demonstrations)
- Working capabilities
- Health of baselines

- Backlog / Roadmap
- Test Plan and Results
- Traceability
- Tool Chains
- Baseline Maturation and Quality
- Agile/DevSecOps Metrics
- Agile Program Operation
- Change Management
- Continuous Improvement

# Framing Oversight for Agile Programs: Review Approach



- Cross functional not stovepipe
- Value focused not compliance focused
- Collaborative not confrontation
- Course correction not velocity reduction
- Continuous improvement not “lines in the sand”

**Review the same way you implement**



# Framing Oversight for Agile Programs: Review Outcomes



- Continuous learning for program and organization
- Ongoing improvements not step functions
- Enhanced value delivery
- Predictable performance
